# The why of this feature

Our goals for adding **AI Project Quality Checks** came from feedback and a desire to Improve overall project quality by identifying for employers how their project scores on learning opportunity, clarity and support offered.

### User outcomes

Our employers were looking for ways to receive more tangible recommendations for how to approve their projects to match with course outcomes. The new feature also helps Riipen to flag projects that could be improved or removed from the marketplace. These enhancements will benefit all users with speed to matching and with more robust projects aligned to course outcomes for overall more impactful experiences.

### Feedback that influenced the feature

"As an educator, I want employers to receive feedback on their projects and make improvements prior to seeing them in the marketplace."

### How it works



#### Step 1

Create a project as an employer.

Behind the scenes, Riipen is checking their project by using AI to assess it against three main criteria:

- · Relevance and learning opportunity
- Clarity of description
- · Quality of mentorship and support



#### Step 2

Each category is then assessed from 1-5, to produce an average score for the project



#### Step 3

The user is sent an email letting them know the outcome of this review and why their project scored as it did in each category.

#### For scores below 3.5:

- · In the email with the evaluation, the user is prompted to edit their project. The project remains open.
- · A flag is created in Forest Admin for the Riipen CS team to review the project and decide whether to remove it from the marketplace.

#### For scores of 3.5 and up:

· In the email with the evaluation, the user is congratulated and told to go find a match. No flag is created.
